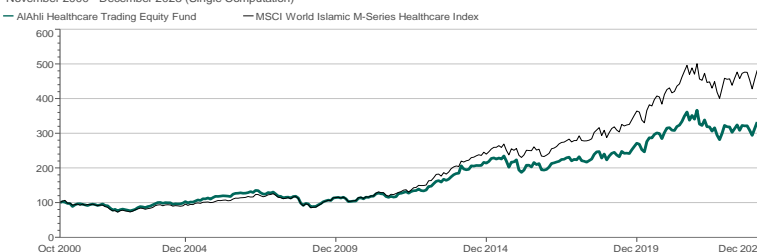

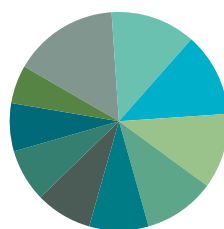
Manager Performance

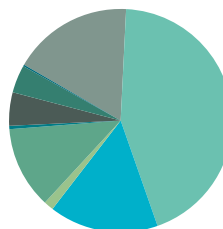
