

## BIBD EASY PAYMENT PLAN PROMOTION - TERMS AND CONDITIONS

The following Terms and Conditions (“Terms”) apply exclusively to the **BIBD EASY PAYMENT PLAN PROMOTION** (“Promotion”) held by Bank Islam Brunei Darussalam Berhad (“BIBD”) from 21 February 2024 until 21 April 2024 (“Promotion Period”).

### 1. PROMOTION PERIOD

1.1. The Promotion will be held during the Promotion Period or such other date(s) as may be determined/varied at BIBD’s sole discretion and as shall be notified by BIBD from time to time.

### 2. ELIGIBILITY

2.1. In order to be eligible for participation in the Promotion, BIBD customers who hold BIBD Mastercard / VISA Credit Cards (World, Platinum, Gold and Classic) (“BIBD Cardholders” and “BIBD Credit Cards” respectively) must make successful transactions using their BIBD Credit Cards through Point of Sale (“POS”) terminals or via online.

2.2. The following BIBD Cardholders shall not be eligible to participate in the Promotion:

- a) BIBD Cardholders whose facilities with BIBD are in delinquent or past due status and/or are facing any form of legal proceedings including bankruptcy proceedings and/or
- b) BIBD Cardholders whose accounts are subject to any form of restrictions or have been closed for whatsoever reason during the Promotion Period.

2.3. For the avoidance of doubt, cash withdrawal transactions of any kind including withdrawals made through any of BIBD’s Automated Teller Machine(s) (“ATMs”) or over the counter for payments will not qualify for purposes of participation in the Promotion.

2.4 All employees of BIBD and its subsidiaries including the Management and Directors of BIBD and its subsidiaries, Members of BIBD’s Shariah Advisory Body (“SAB”) and the SABs of the respective subsidiaries are eligible to participate in this Promotion.

- 4.4. BIBD shall not be held liable for any and/or all form of losses or damage suffered or incurred by the cardholders as a direct or indirect result of any extension, cancellation, termination, or suspension of the Promotion.
- 4.5. In the event of any inconsistency in the Terms and any marketing or promotional materials relating to the Promotion, these Terms shall prevail.
- 4.6. BIBD's decision on any or all matters relating to the Promotion shall be final and absolute.
- 4.7. These Terms shall be governed by and construed in accordance with the Laws of Brunei Darussalam and the Courts of Brunei Darussalam shall have exclusive jurisdiction to hear any disputes or claims pertaining hereto.
