

BIBD CREDIT CARD PRIVILEGE PROMOTION TERMS AND CONDITIONS - BIBD X MEGAHOME GROUP CAMPAIGN

The following Terms and Conditions (“**Terms**”) apply exclusively to the **BIBD CREDIT CARD PRIVILEGE PROMOTION** (“**Promotion**”) held by Bank Islam Brunei Darussalam Berhad (“**BIBD**”) (Company Registration No. RC00006420).

1. PROMOTION PERIOD

- 1.1 The Promotion will take place from **24 June 2024 until 24 July 2024** (“**Promotion Period**”) or such other date(s) as may be determined/varied and notified by BIBD, at its sole discretion from time to time.

2. ELIGIBILITY

- 2.1 This Promotion is exclusively for BIBD Customers holding BIBD Credit Cards (“**Cardholders**”) whose account(s) are in good standing.
- 2.2 The following Cardholders shall not be eligible or qualified to participate in this Promotion:
- a) Cardholders whose accounts have been suspended, cancelled or terminated for whatsoever reasons during the Promotion Period; and/or
 - b) Cardholders whose accounts with BIBD are in delinquent or past due status and/or those who are facing any legal proceedings including bankruptcy proceedings.
- 2.3 Successful retail transactions made using BIBD Mastercard / VISA Credit Cards (World, Platinum, Gold and Classic) (collectively “**BIBD Credit Cards**”) at any of the participating merchants’ outlets/branches (“**Participating Merchants**”) will be eligible for participation in this Promotion.
- 2.4 For the avoidance of doubt, cash withdrawal transactions of any kind including withdrawals made through any of BIBD’s Automated Teller Machine(s) or over the counter will not qualify for purposes of inclusion in the Promotion.
- 2.5 All employees of BIBD and its subsidiaries including the Management and Directors of BIBD and its subsidiaries (“**BIBD Group**”), Members of BIBD’s Shariah Advisory Body (“**SAB**”) and its subsidiaries and employees of Megahome Depot Enterprise, Elegance Lighting & Electrical Enterprise and Ztree Sdn Bhd are **eligible** to participate in this Promotion.

3. PROMOTION MECHANICS

3.1 During the Promotion Period, transactions made with BIBD Credit Cards which are approved, cleared and settled through **BIBD Point of Sale (POS) terminals at the Participating Merchants' outlets/branches** will be eligible for the following discount:

3.2 If BIBD subsequently determines that a Cardholder is ineligible or is not entitled to a discount for any reason whatsoever, BIBD has the sole discretion to reclaim the discount.

- 5.3 Any disputes with regards to the discount should be resolved directly with Megahome Depot Enterprise; Elegance Lighting & Electrical Enterprise; Ztree Sdn Bhd and subject to Megahome Depot Enterprise; Elegance Lighting & Electrical; Ztree Sdn Bhd terms and conditions.
- 5.4 BIBD reserves the right to amend or modify any of these Terms either wholly or partly at any time with a minimum of 3 days' notice to the Cardholders.
- 5.5 BIBD shall not be held liable for any and/or all form of losses or damages suffered or incurred by the Cardholders as a direct or indirect result of the extension, cancellation, termination or suspension of the Promotion or due to any events beyond the reasonable control of BIBD.
- 5.6 In the event of any inconsistency between these Terms and any marketing or promotional materials relating to the Promotion, these Terms shall prevail.
- 5.7 BIBD's decision on any or all matters relating to the Promotion shall be final, conclusive and binding and no correspondence, queries, appeals or attempts to dispute such decision shall be entertained.
- 5.8 These Terms shall be governed by and construed in accordance with the Laws of Brunei Darussalam and the Courts of Brunei Darussalam shall have exclusive jurisdiction to hear any disputes or claims pertaining hereto.
