

#### **BIBD HOME FINANCING CAMPAIGN**

The following Terms and Conditions ("**Terms**") shall apply exclusively to the BIBD Home Financing Campaign ("**Campaign**") held by Bank Islam Brunei Darussalam Berhad ("**BIBD**").

#### 1. CAMPAIGN PERIOD

- 1.1 The Campaign will be held from 12 July 2024 to 12 January 2025 ("Campaign Period"), or such other date(s) as may be varied or determined by BIBD at its discretion and notified to the customers from time to time.
- 1.2 Customers may be entitled to participate in the Campaign when they apply for Home Financing facilities from BIBD for fully constructed/practically completed properties or vacant land.

#### 2. ELIGIBILITY

- 2.1 The Campaign is open to all new or existing BIBD Customers who satisfy all the financing criteria and requirements prescribed by BIBD for eligibility to apply for Home Financing products.
- 2.2 In order to qualify for the Campaign, the Home Financing products must have a minimum tenure of ten (10) years.
- 2.3 Home Financing applications must be made during the Campaign Period and <u>approved before 12</u> <u>February 2025.</u>
- 2.4 During the Campaign Period, only approved applications by BIBD will qualify for inclusion in the Campaign and will entitle the customers to entries to the respective draws ("Entries").
- 2.5 Customers whose accounts have been suspended, cancelled, or terminated for whatsoever reasons during the Campaign Period shall automatically be disqualified from the Campaign.

  - 2.6.3 Minors or individuals under the age of eighteen who are under the legal guardianship of Non-Eligible Persons.

- 5.2 Winners will be notified by telephone and/or via SMS or such mode of communication deemed feasible by BIBD.
- 5.3 The winners hereby authorize and consent to the public disclosure of their names, pictures, or any other details in any form of media or as determined by BIBD for advertising, publicity or commercial purposes.
- 5.4 During the prize presentation event, winners are required to attend the event for prize collection. In the event that a winner is unable to attend the prize presentation event for whatever reason, BIBD may, at its sole discretion, allow the winner to nominate a representative to accept/collect the prize on the winner's behalf subject to the following:

- 6.6 BIBD reserves the right to extend, cancel, terminate, or suspend the Campaign and its related events at any time without assigning any reasons whatsoever with prior notice.



- 6.7 For the avoidance of doubt, any extension, cancellation, termination, or suspension of the Campaign shall not entitle the eligible customer for any claim or compensation against BIBD and for any and/or all losses or damages suffered or incurred by customer as a direct or indirect result of the act of extension, cancellation, termination, or suspension of the Campaign.
- 6.8 In the event of any inconsistency between these Terms and any other brochure, marketing or promotional materials relating to this Campaign, these Terms shall prevail.
- 6.9 BIBD shall not be liable for any losses, damages or expenses arising out of or in connection with the Campaign due to any event beyond the reasonable control of BIBD.
- 6.10 BIBD's decision on any or all matters relating to the Terms shall be final, conclusive, and binding and no correspondences, queries, appeals or attempts to dispute such decision shall be entertained.
- 6.11 These Terms shall be governed by and construed in accordance with the Laws of Brunei Darussalam and the Courts of Brunei Darussalam shall have exclusive jurisdiction to hear any dispute or claim arising hereunder.
