

### BIBD CREDIT CARD PRIVILEGE PROMOTION TERMS AND CONDITIONS - AV ELECTRONICS SDN BHD

The following Terms and Conditions ("Terms") apply exclusively to the BIBD Credit Card Privilege Promotion ("Promotion") held by Bank Islam Brunei Darussalam Berhad [RC00006420] ("BIBD").

#### 1. PROMOTION PERIOD

1.1. The Promotion will take place from <u>27 September 2024 until 31 October 2024</u> ("Promotion Period") or such other date(s) as may be determined/varied by BIBD, at its sole discretion from time to time.

### 2. ELIGIBILITY

- 2.1. The Promotion is open to all new and existing BIBD Credit Cardholders holding BIBD Mastercard / VISA Credit Cards (World, Platinum, Gold and Classic) ("Cardholders" and "BIBD Cards" respectively) whose account(s) are in good standing with BIBD.
- 2.2. The following Cardholders shall not be eligible or qualified to participate in the Promotion:
  - a) Cardholders whose accounts have been suspended, cancelled or terminated for whatsoever reasons during the Promotion Period; and/or
  - b) Cardholders whose accounts with BIBD are in delinquent or past due status and/or those who are facing any legal proceedings (including bankruptcy proceedings).
- 2.3. For the avoidance of doubt, cash withdrawal transactions of any kind including withdrawals made through any of BIBD's Automated Teller Machine(s) or over the counter will not qualify for purposes of inclusion in the Promotion.

- 5.4. BIBD shall not be held liable for any and/or all form of losses or damages suffered or incurred by the Cardholder as a direct or indirect result of the extension, cancellation, termination or suspension of the Promotion.



- 5.5. In the event of any inconsistency between these Terms and any marketing or promotional materials relating to the Promotion, these Terms shall prevail.
