

**BIBD CARD PRIVILEGE PROMOTION TERMS AND CONDITIONS - ARTYZEN AUTOLAB COMPANY**

The following Terms and Conditions (“Terms”) apply exclusively to the **BIBD CARD PRIVILEGE PROMOTION** (“Promotion”) held by Bank Islam Brunei Darussalam Berhad (“BIBD”) (Company Registration No. RC00006420).

**1. PROMOTION PERIOD**

- 1.1. The Promotion will take place from **01 March 2026 until 31 March 2026** (“Promotion Period”) or such other date(s) as may be determined/varied and notified by BIBD, at its sole discretion from time to time.

**2. ELIGIBILITY**

- 2.1 This Promotion is exclusively for BIBD Customers holding BIBD Mastercard / VISA Credit Cards (World, Platinum, Gold and Classic) and BIBD MasterCard Debit Cards (“Cardholders” and “BIBD Cards” respectively) whose account(s) are in good standing with BIBD.
- 2.2 The following Cardholders shall not be eligible or qualified to participate in this Promotion:
  - a) Cardholders whose accounts have been suspended, cancelled or terminated for whatsoever reasons during the Promotion Period; and/or
  - b) Cardholders whose accounts with BIBD are in delinquent or past due status and/or those who are facing any legal proceedings including bankruptcy proceedings.
- 2.3 Successful retail transactions made using **BIBD Cards** at the following ARTYZEN AUTOLAB COMPANY location will be eligible for participation in this Promotion:
  - a) Ground Floor, No.10, Block A, Spg 188, Jalan Pengiran Babu Diraja, BSB BC1318
- 2.4 For the avoidance of doubt, cash withdrawal transactions of any kind including withdrawals made through any of BIBD’s Automated Teller Machine(s) (“ATMs”) or over the counter will not qualify for purposes of inclusion in the Promotion.
- 2.5 All employees of BIBD and its subsidiaries, including the respective Management, Directors and members of Shariah Advisory Body (“**BIBD Group**”) are **eligible** to participate in this Promotion.
- 2.6 All employees of ARTYZEN AUTOLAB COMPANY are **eligible** to participate in this Promotion.

- 3.1. During the Promotion Period, transactions made by **BIBD Cardholders that are approved and cleared through BIBD Point-of-Sale (“POS”) terminal** will be eligible for the offer, subject to the following conditions:

- 4.2. Any disputes in relation to the offer should be resolved directly with ARTYZEN AUTOLAB COMPANY and shall also be subject to ARTYZEN AUTOLAB COMPANY terms and conditions.
- 4.3. The Term contained herein are in addition and without prejudice to BIBD Cards' terms and conditions including the usage of BIBD Cards for Shariah-compliant transactions only.
- 4.4. BIBD reserves the right to amend or modify any of these Terms either wholly or partly at any time with minimum 3 business days' notice to Cardholder.
- 4.5. BIBD shall not be held liable for any and/or all form of losses or damages suffered or incurred by the Cardholders as a direct or indirect result of the extension, cancellation, termination or suspension of the Promotion or due to any events beyond the reasonable control of BIBD.
- 4.6. In the event of any inconsistency between these Terms and any marketing or promotional materials relating to the Promotion, these Terms shall prevail.
- 4.7. BIBD decision on any or all matters relating to the Promotion shall be final, conclusive and binding and no correspondence, queries, appeals or attempts to dispute such decision shall be entertained.
- 4.8. By participating in this Promotion, the Cardholders acknowledge and agree that Bank Islam Brunei Darussalam Berhad ("BIBD") may collect, use and disclose their personal data for purposes relating to the administration and fulfilment of this Promotion, including but not limited to verifying eligibility, contacting Cardholders, and any other purposes reasonably related to the Promotion.
- 4.9. All personal data collected in connection with this Promotion will be managed securely and used only for the purposes stated above.
