

**BIBD CREDIT CARD PRIVILEGE PROMOTION TERMS AND CONDITIONS - JUST PURE DROPS COMPANY**

The following Terms and Conditions (“**Terms**”) apply exclusively to the BIBD CARD PRIVILEGE PROMOTION (“**Promotion**”) held by Bank Islam Brunei Darussalam Berhad (“**BIBD**”).

**1. PROMOTION PERIOD**

- 1.1. The Promotion will take place from **1 July 2026 until 31 July 2026 (“Promotion Period”)** or such other date(s) as may be determined/varied and notified by BIBD, at its sole discretion from time to time.

**2. ELIGIBILITY**

- 2.1. This Promotion is exclusively for BIBD Customers holding BIBD Mastercard / VISA Credit Cards (World, Platinum, Gold and Classic) (“**Credit Cardholders**” and “**BIBD Credit Cards**” respectively) whose account(s) are in good standing with the Bank.
- 2.2. The following Credit Cardholders shall not be eligible or qualified to participate in the Promotion:
- a) Credit Cardholders whose accounts have been suspended, cancelled or terminated for whatsoever reasons during the Promotion Period; and/or
  - b) Credit Cardholders whose accounts with BIBD are in delinquent or past due status and/or those who are facing any legal proceedings including bankruptcy proceedings.
- 2.3. Successful retail transactions made using BIBD Credit Cards at **Just Pure Drops Company** located at **Unit 3, Block A, Qlap Complex, Kg Kiulap, BSB BE1518, Brunei Darussalam** during the Promotion Period will be eligible for participation in this Promotion.
- 2.4. For the avoidance of doubt, cash withdrawal transactions of any kind including withdrawals made through any of BIBD’s Automated Teller Machine(s) (“**ATMs**”) or over the counter will not qualify for purposes of inclusion in the Promotion.
- 2.5. All employees of BIBD and its subsidiaries, including the respective Management, Directors of BIBD and members of Shariah Advisory Body (“**BIBD Group**”) and employees of Just Pure Drops Company are **eligible** to participate in this Promotion.

**3. PROMOTION MECHANICS**

- 3.1. During the Promotion Period, transactions made by BIBD Credit Cards which are approved, cleared and settled through BIBD Point-of-Sale (“**POS**”) terminals at Just Pure Drops Company will be eligible for the discount, subject to the following conditions:

- 4.2. The Terms contained herein are in addition and without prejudice to BIBD Credit Cards' terms and conditions including the usage of BIBD Credit Cards for Shariah-compliant transactions only.
- 4.3. BIBD reserves the right to amend or vary any of these Terms at any time at with minimum three (3) business days' notice to customer.
- 4.4. BIBD shall not be held liable for any and/or all form of losses or damages suffered or incurred by the Credit Cardholders as a direct or indirect result of the extension, cancellation, termination or suspension of the Promotion.
- 4.5. In the event of any inconsistency between these Terms and any marketing or promotional materials relating to the Promotion, these Terms shall prevail.
- 4.6. BIBD decisions on any or all matters relating to the Promotion shall be final, conclusive and binding and no correspondence, queries, appeals or attempts to dispute such decision shall be entertained.
- 4.7. By participating in this Promotion, the Cardholders acknowledge and agree that Bank Islam Brunei Darussalam Berhad ("BIBD") may collect, use and disclose their personal data for purposes relating to the administration and fulfilment of this Promotion, including but not limited to verifying eligibility, contacting Credit Cardholders, and any other purposes reasonably related to the Promotion.
- 4.8. All personal data collected in connection with this Promotion will be managed securely and used only for the purposes stated above. BIBD is committed to protecting personal data in accordance with its internal policies, the Personal Data Protection Order (PDPO) 2025 of Brunei Darussalam, and BIBD's Privacy Policy, as may be amended from time to time.
