

BIBD CREDIT CARD PRIVILEGE PROMOTION TERMS AND CONDITIONS - IMAGINE SDN BHD (“imagine**”)**

The following Terms and Conditions (“**Terms**”) apply exclusively to the **BIBD CREDIT CARD PRIVILEGE PROMOTION (“Promotion”)** held by Bank Islam Brunei Darussalam Berhad (“**BIBD**”).

1. PROMOTION PERIOD

- 1.1. The Promotion will be held from **1 August 2026 until 31 August 2026 (“Promotion Period”)** or such other date(s) as may be determined/varied and notified by BIBD, at its sole discretion from time to time.

2. ELIGIBILITY

- 2.1. The Promotion is open to all new and existing BIBD Customers holding BIBD Mastercard / VISA Credit Cards (World, Platinum, Gold and Classic) (collectively referred to as “**BIBD Credit Cardholders**” and “**BIBD Credit Cards**” respectively) whose accounts are in good standing with BIBD.
- 2.2. The following BIBD Credit Cardholders shall not be eligible or qualified to participate in the Promotion:
- a) BIBD Credit Cardholders whose accounts have been suspended, cancelled or terminated for whatsoever reasons during the Promotion Period; and/or
 - b) BIBD Credit Cardholders whose accounts with BIBD are in delinquent or past due status and/or those who are facing any legal proceedings (including bankruptcy proceedings).
- 2.3. Successful retail transactions made using BIBD Credit Cards at any participating imagine outlets as stated in Clause 3.1 will be eligible for participation in this Promotion.
- 2.4. For the avoidance of doubt, cash withdrawal transactions of any kind including withdrawals made through any of BIBD’s Automated Teller Machine(s) (“**ATMs**”) or over the counter will not qualify for purposes of inclusion in the Promotion.
- 2.5. All employees of BIBD and its subsidiaries, including the respective Management, Directors and members of Shariah Advisory Body (“**BIBD Group**”) and employees of imagine are **eligible** to participate in this Promotion.

- 5.1. By participating in the Promotion, the BIBD Credit Cardholders expressly agree to be bound by these Terms.
- 5.2. BIBD and imagine reserve the right to determine the eligibility of BIBD Credit Cardholders for the Promotion.
- 5.3. The Terms contained herein are in addition and without prejudice to BIBD Credit Cards' terms and conditions including the usage of BIBD Credit Cards for Shariah-compliant transactions only.

- 5.4. BIBD reserves the right to amend or modify any of these Terms either wholly or partly at any time with minimum three (3) business days' notice to BIBD Credit Cardholders.
- 5.5. BIBD shall not be held liable for any and/or all form of losses or damages suffered or incurred by the BIBD Credit Cardholders as a direct or indirect result of the extension, cancellation, termination or suspension of the Promotion or due to any events beyond the reasonable control of BIBD.
- 5.6. In the event of any inconsistency between these Terms and any marketing or promotional materials relating to the Promotion, these Terms shall prevail.
- 5.7. BIBD decision on any or all matters relating to the Promotion shall be final, conclusive and binding and no correspondence, queries, appeals or attempts to dispute such decision shall be entertained.
- 5.8. By participating in this Promotion, the BIBD Credit Cardholders acknowledge and agree that BIBD may collect, use and disclose their personal data for purposes relating to the administration and fulfilment of this Promotion, including but not limited to verifying eligibility, contacting BIBD Credit Cardholders, and any other purposes reasonably related to the Promotion.
- 5.9. All personal data collected in connection with this Promotion will be managed securely and used only for the purposes stated above. BIBD is committed to protecting personal data in accordance with its internal policies, the Personal Data Protection Order (PDPO) 2025 of Brunei Darussalam, and BIBD's Privacy Notice, as may be amended from time to time. - 5.10. These Terms shall be governed by and construed in accordance with the Laws of Brunei Darussalam and the Courts of Brunei Darussalam shall have exclusive jurisdiction to hear any disputes or claims pertaining hereto.
